Corporate and/or business checks are not eligible. Arizona Revised Statutes Section 43-1089.01(G)(2)(d) defines extracurricular activities as school-sponsored activities that supplement the school's educational program and may require enrolled students to pay a fee in order to participate. Please check with the school if you have questions about specific program eligibility.

**Please Note:** When submitting in person or mailing your contribution, the above complete information is required in order for this contribution to be used as a TAX CREDIT on your 2021 Arizona State Income report. If the information is incomplete, your contribution and form may be returned to you. Tax credits must be RECEIVED by April 15, 2022. If not paying in person or online, please mail the completed form to: Tax Credits, Kyrene School District No. 28, 8700 South Kyrene Road, Tempe, AZ 85284.
